Module: Pharmacist Administered Immunization

Administration

- o Does the pharmacist need to register with the Board before administering vaccines?
- What type of course, including CPR and ongoing CE, is required?
- o May a licensed intern/ graduate extern administer vaccines?
- O What vaccines can a pharmacist administer?

Location

Are there restrictions on location within the building on where vaccines may be administered? Is
off-site administration by pharmacists allowed and if so, what regulations apply?

Procedure

- 1. If "protocol" is required (e.g., a protocol, standing order or other non-patient specific document)
 - O What vaccines can be administered pursuant to a "protocol"?
 - O What clauses are required in an immunization protocol?
 - What licensure, residency, active practice, and/or location requirements exist for the protocol physician?
 - o Is board notice or approval of the protocol required?

2. Documentation

- Pharmacy recordkeeping for vaccine administration
- o Patient documentation: what documents must be provided to the patient?
- o Patient Screening: Does the state require use of specific patient screening questions?

3. Reporting:

- o Reporting requirements to the protocol/ authorizing physician and PCP.
- o Is the pharmacy required to report immunizations to the state?
- Patient Opt-In/ Opt-Out reporting requirements to state, if applicable.

4. Emergency Medications

 Is a standing order adequate authority for the pharmacist to prescribe, dispense, and administer emergency medications?

5. Preservative-free requirements

 Are preservative free vaccines required in any circumstances (e.g., pregnant women or children)?

6. Facility

- What additional requirements relating to facility and equipment exist when vaccinations are administered in the pharmacy setting?
- o Are privacy restrictions that apply when a pharmacist is vaccinating a patient?

7. Waste:

Does the state require the pharmacy to obtain a biomedical waste permit?

O What requirements exist for the disposal of sharps or vaccine vials?

8. VFC Program:

- If the state has a Vaccine for Children program, is the pharmacy required to participate in VFC in order to provide vaccinations to children?
- O What are the steps for enrolling in VFC?
- What are the ongoing compliance and operational requirements for pharmacies participating in the VFC program?

9. Billing for Services

- o What does the state board require for a vaccine claim to be processed?
- Medicaid Requirements
- ON the CMS Form 1500, do vaccines need be billed using the protocol practitioner's ID number or the pharmacist's ID number

Module: State Immunization Schedules for Children and Health Care Workers

- State's school and childcare vaccination requirements
