### **Application Criteria & Requirements:**

- Applicants must demonstrate financial need and interest in participating in a COC Community Program
- Applicants may apply for a bursary for more than one program per season
- The amount awarded to individuals is based on the number of applications received and the financial need of the applicants. The COC cannot guarantee that full or partial bursaries will be awarded to all applicants.

- Submit a completed bursary application form by May 17, 2024
- Provide a tax slip and/or a letter from any employer(s)/social service agency confirming the total family income

Applications will not be reviewed unless all portions of the application form are completed and received.

The deadline for all bursary applications will be May 17, 2024; however, bursaries will be awarded on an ongoing basis, so it is best to apply as early as possible.
