Since English was not his first language, Andrii spent his first year at Royal Vale immersing himself in the language, visiting the school library regularly at lunchtime to practice reading as well as participating in the school's production of A Midsummer Night's Dream. Now, having established a solid foundation in English, he is onto French and regularly borrows books to practice on his own. Andrii's learning efforts go beyond the acquisition of new language skills; an insatiable curiosity means he is always learning and exploring. In the classroom and amongst friends, Andrii is a very gentle and friendly person and his positive attitude is valued by students and staff alike.

We would also like to recognize the Student of the Month for the month of October and November.

Student of the Month for October: The EMSB's co-Students of the Month for October are Owen Graham-Roache and Biagio Daniele Jr. Both Owen and Biagio are Secondary 5 Sport-Études students who attend the EMSB's Virtual Academy, and despite their intense athletic schedules, both still maintain a full academic workload. Respectively, Owen is a striker for the CF Montreal U18 team and has been a member of the CF Montreal Development Program for three years and Biagio will begin his first full season with the Acadie-Bathurst Titans of the QMJHL this fall after being selected 9th overall in the 2024 draft. Student of the Month for November: The Students of the Month for November are Lucas & Layla Levy (Grade 4) from Merton Elementary School in Cote Saint Luc. Since the tragic passing of their mother two years ago, Lucas and Layla have demonstrated incredible resilience to keep their mother's memory alive as well as help other children who have suffered a loss. For the past two years, Lucas & Layla have benefitted from the help of Myra's Kids Foundation to cope with their grief and used these tools to heal other broken hearts in Montreal. Additionally, the siblings have been actively raising funds for the Lighter Fund, which was set up in memory of their mother. Through lemonade stands and by selling handmade bracelets, stickers and crafts on Monkland Avenue, they have raised \$5,000 to support Mental Health projects at the Douglas Mental Health Mobile Outreach Program as well as for Myra's Kids Foundation. These children are incredible role models and are examples of how to triumph over tragedy and help others do the same.

As of Monday, January 27th, at 7 a.m., reservations will open at 23 Elementary Schools, a big jump from the 5 that launched the original pilot project. - Congratulations to music teachers Christine Crawford and 19 of her students at Carlyle Elementary School for successfully completing what may well be the EMSB's first flash mob. It took place during lunch hour on December 11th at the Le Fou Fou Food Hall at the sprawling Royalmount shopping complex. The children sang three beautiful songs and as flash mobs go, they surfaced while people were dining as a total surprise. Principal, Dina Vourdousis was very proud of her students as are all of we;
- ➤ For a third year, the Italian Government's Ministry of International Cooperation, along with the support of the Consulate General of Italy, has granted 3 EMSB Elementary schools including Dante, Pierre de Coubertin and Honoré Mercier, an amount of \$17 030 in funding for their integrated PELO Program;
- The Girls Group from John F. Kennedy High School are once again kicking off the holiday season with their Shoebox Project, an initiative to fill 125 shoe boxes with essential items which will be donated to woman shelters across Montreal. An initiative of teacher Marietta Damiano and a select group of grade 11 girls, the Shoebox Project was started last holiday season to brighten up a very difficult time of the year for at-risk women in Montreal. Each shoe box to be filled with essential items such as shampoo, conditioner, body wash, etc. Congratulations to the entire team at the school for this wonderful initiative;

- The 2024-2025 Fall edition of the Inspirations Newspaper is now available online and is in our schools. This edition's positive mental health and well-being section featuring articles written by EMSB Student Services specialist, is rich with helpful information on how the home and school connection bolsters mental health facts and tips for parents about sexting and much more. This edition also features research related to Autism, inspiring success stories, a celebration of Simon Chang difference makers, the Leaders on Wheels at the Mackay Centre and Satellite class at Westmount High School;
- Following an annual tradition, 10 EMSB schools came together on December 11th at Gerald McShane Elementary School to wrap thousands of pairs of socks for local charities. Congratulations to all students who participated in this activity;
- ➤ Westmount High School hosted members of a Selection Committee on the impacts of screens and social media on young people's health and development from the National Assembly of Quebec. The Committee participated in a facilitated dialogue in English and French with selected students regarding screens and social media;
- Matt Gilmour from CTV News recently visited East Hill Elementary School to prepare a story about how the internet, social media and screen time are affecting young people. He wanted to see and hear about the way East Hill's media teacher, Nadia Barrafato educates East Hill students about digital citizenship;

18. Committee Reports

18.1 ACSES (Advisory Committee on Special Education Services)

Item presented by the Parent Commissioner of the Committee, Ms. Julie Kristof:

- The Advisory Committee for Special Education (or ACSES) met twice this school year, once on September 30th and then on November 25th;
- The student services team presented a new program called Sequia which is a program at JFK for special learners, no exams and greater attention. This is the first year and it is amazing how innovative programs are being tried to include all our kids. We've also learned about anti-bullying initiatives and anti-troll kits;
- ACSES has been working with student services to create parent and student tool kits for EMSB's Prevention Promotion portal. This is a hidden gem of resources that address mental health, academic support, violence prevention among many other topics. Last year ACSES, with EPCA, produced materials about IEP's, parent-teacher interviews and how to advocate for your child effectively. This year our sub-committee has begun work collecting information about "sexting" and communication skills;
- There is always concern over resources for our special needs kids, waiting lists for professionals and staffing. At our last meeting, student services presented some data for us to consider/chew on and the challenges associated with a growing proportion of EMSB students with codes and IEPs;
- On a personal note, it is thrilling to see some of the innovative projects happening at John Grant high school, my daughter's school. One project is to start a garden outdoors and a greenhouse with the intention to obtain competencies towards stage and to supply our kitchen with fresh produce. The kids were so proud that their first basil harvest was used in the cafeteria this week!

18.2 EMSBPC (English Montreal School Board Parents' Committee)

Item presented by Parent Commissioner, Ms. Merika Ramundo:

- The EMSB Parents Committee has met twice. At the December 5 meeting, three EMSB Educational Services teams presented on Indigenous Initiatives, Elementary Literacy Projects, STEAM Initiatives. The EMSB PC thanks them for their time and expertise;
- > Several questions and concerns were raised with EMSB senior administration on the following topics:
 - 1. **School Websites:** Parents emphasized the importance of up-to-date and accurate school websites as key tools for communication and promotion. Concerns were noted about update delays, occasional inaccuracies, and the balance between standardization and personalization of sites across the system.
 - 2. **Service Account Emails for governing boards:** Governing Board delegates highlighted the benefits of using a service account email address for continuity purposes, archiving, streamlining and formalizing communications. However, senior administration confirmed these accounts for governing boards are not permitted, with correspondence required to go through the school principal. The Parents Committee will follow up for further clarification, particularly regarding alignment with the *Education Act* and best practices in governance. The aim is to foster clearer and more transparent communication between parents, governing boards and administration.
 - 3. Educational Project Surveys: Concerns were raised about inconsistencies in the implementation and data collection process during the rollout of the educational project survey across the school board last year. Senior administration clarified that survey execution is at the discretion of school principals, with no standardized process planned. The Parents Committee will continue to explore this issue as it relates to the Education Act and related activities to better understand the approach and potential for greater consistency.

On December 13th, the collective *Pas une mort de plus* held a rally to mark the second anniversary of the death of young Mariia in Montreal in 2022 and to advocate for road safety reforms. A motion to support the collective's proposals and sign their letter advocating for change was passed unanimously by the EMSB Parent Committee.

18.3 Governance and Ethics Committee

Item presented by the Chair of the Committee, Mr. Mario Pietrangelo:

➤ The Committee met twice on November 28, 2024, and December 12, 2024 for the nominations and election of members on the various committees.

18.4 CGTSIM (Comité de gestion de la taxe scolaire de l'île de Montréal)

Item presented by the Representative Member on the Committee, Mr. Joe Ortona:

- Mr. Ortona was unable to attend the meeting on October 24th, as there was a Bill 40 fundraiser on the same night, which was very well attended;
- Mr. Ortona attended the meeting on December 5th, where many of the items were discussed In Camera. There were positions and vacancies that were filled;
- We welcomed our new substitute member on the committee, Ms. Paula Kilian;
- They received various updates on the financing of the allocations for the milieu défavorisé, on the régime de gestion des risques, on la loi sur la gestion et le contrôle des effectifs for a certain period and recommendations that were received by SIMConseil. We will continue to follow the situation regarding the mileu défavorisé and the money allocations that are coming. The School Board will be getting these monies in January.

18.5 EMSAC (English Montreal Student Advisory Committee)

Item presented by the Observer, Mr. Joe Ortona:

- Mr. Ortona had the pleasure of attending in November an EMSAC meeting. Watching the students discuss about all sorts of various issues that affect them and they had a very interesting discussion on the topic of artificial intelligence (AI) that dominated the agenda. They discussed about how it can be used for assignments and how you know sometimes where that line is as some students use it to draft assignments in full and of course that is plagiarism. However, they sometimes use it to correct spelling or grammar or just to tweak a paper that they wrote. Following this, they discussed about the tools that identify whether you know AI wrote a paper or not and how reliable they could be. Some students gave examples that they wrote papers that were 80% AI generated. All in all, it was nice to see the students having grown up conversations and how they understand the issues;
- ➤ There was another meeting held on December 16th, however the Chair was unable to attend.

19. Commissioners' Report

Item presented by Vice-Chair, Mr. James Kromida:

Mr. Kromida attended LaurenHill where they had an exceptional visit and presentation by Mr. Ian Halperin, a world famous individual author. Mr. Halperin spoke about racism and antisemitism, how it festered, how to deal with it in such a mature and intelligent way. It gave people hope and you could see everyone there was spellbound. It was a really wonderful experience and Mr. Kromida commended Mr. Mike Cohen, his department and everyone involved in the organization of such events which make a difference in our students.

Item presented by Commissioner, Mr. Pietro Mercuri:

- ➤ Mr. Mercuri commended the extraordinary work of Ms. Nadia Barrafato, the media teacher at East Hill Elementary School. CityNews recently reported on the incredible work being done to educate our children about digital citizenship;
- Leonardo Da Vinci Academy held their holiday concert on December 12th which also doubled up as a fundraiser event where just over \$6,000 was raised in gift cards and donations. These were collected and given to Saint Brendan's Parish that services Montreal's English-speaking community;
- Finally, Mr. Mercuri wished everyone in Ward 6, teachers, principals, parents and students a very joyous and healthy holiday season.

Item presented by Commissioner, Ms. Maria Corsi:

- Pon this day, Ms. Corsi had the pleasure of attending the family holiday breakfast at Dalkeith Elementary School. The school was a buzz with holiday spirit as families enjoyed a delicious breakfast followed by various activities including arts and crafts, face painting and a photo booth. A group of entrepreneurial, cycle three students set up tables to sell craft kits and holiday treats to raise money for their Grade 6 graduation. A big thank you to Principal, Mr. John Wright for the invitation to this great holiday event. Ms. Corsi also wanted to shine the spotlight on the driving force who was responsible for its organization and execution, Dalkeith's long time extraordinary volunteer, Ms. Patty Smythe. Ms. Patty not only baked the goods for the breakfast, but she also transformed Dalkeith into a magical holiday landscape with decorations and of course with the support from the staff;
- On November 26th, the Secondary 3 students from Rosemount High School visited the Holocaust Museum. The Chair, Principal of Rosemount High School, Mr. Iammarone, Commissioner, Ms. Samuel and Ms. Corsi herself were also there to highlight not only the importance of Holocaust education, but also to acknowledge the generous contributions made by the Federation CJA to support the EMSB's Holocaust Education Program;
- ➤ On November 13th, FedEx made a special delivery to students at Edward Murphy Elementary School bringing a coat to every student as part of operation Warm. This operation is a national non-profit that manufactures brand-new high-quality coats and shoes for children in need;

- Ms. Kilian had the pleasure of attending Royalmount where Carlyle's Flash Mob sang beautifully. The spectators were very moved and had a rousing applause;
