



**PUBLIC NOTICE – JUNE 14, 2023**  
**SCHOOL BOARD ELECTIONS – PROPOSED ELECTORAL DIVISIONS**

Public Notice is hereby given that the Council of Commissioners of the English Montreal School Board has adopted a proposal for the ten (10) electoral divisions on the Board's territory for the purposes of the general election of school commissioners to be held on November 3, 2024.

If the public wishes to examine the electoral divisions they may do so by presenting themselves at the Administration Building, 6000 Fielding Avenue, Montreal (Quebec) between 9:00 a.m. and 4:00 p.m. Monday to Friday or on the Board's website at [www.emsb.qc.ca](http://www.emsb.qc.ca).

**Notice to readers**

The use of a roadway or a railway implies the median line thereof, unless otherwise specified.

The use of the back line of a roadway means that the boundary of the electoral ward extends along the back of the properties whose addresses have frontage on the roadway mentioned. The side of said roadway is specified by a cardinal point (north, south, east or west).

The electoral wards are delimited as follows:

**Electoral division no 1: (7,740 voters)**

Consisting of that part of the Ville de Montréal corresponding to the borough of Ahuntsic-Cartierville.

Also includes that part of the Ville de Montréal corresponding of the borough of Montréal-Nord.

**Electoral division no 2: (6,105 voters)**

Consisting of that part of the Ville de Montréal corresponding of that portion of the borough of Côte-des-Neiges–Notre-Dame-de-Grâce lying easterly of the following road circuit: commencing at the intersection of rue Dufferin and chemin de la Côte-Saint-Luc, this road, avenue Marcil, boulevard De Maisonneuve Ouest, avenue Girouard and the extension of said avenue.

**Electoral division no 3: (9,447 voters)**

Includes the Ville de Hampstead.

Also includes the Ville de Côte-Saint-Luc.

Also includes the Ville de Montréal-Ouest.



**Electoral division no 4: (8,283 voters)**

Includes that part of the Ville de Montréal corresponding to the borough of Anjou.

Also includes that part of the Ville de Montréal corresponding to the borough of Mercier–Hochelaga-Maisonneuve.

Also includes that part of the Ville de Montréal corresponding to the borough of Plateau-Mont-Royal.

Also includes that part of the Ville de Montréal corresponding to the borough of Rosemont–La Petite-Patrie.

Also includes the Ville de Montréal-Est.

**Electoral division no 5: (7,134 voters)**

Consisting of that part of the Ville de Montréal corresponding of that portion of the borough of Côte-des-Neiges–Notre-Dame-de-Grâce lying westerly of the following road circuit: commencing at the intersection of rue Dufferin and chemin de la Côte-Saint-Luc, this road, avenue Marcil, boulevard De Maisonneuve Ouest, avenue Girouard and the extension of said avenue.

**Electoral division no 6: (8,989 voters)**

Consisting of that part of the Ville de Montréal corresponding to the borough of Rivière-des-Prairies–Pointe-aux-Trembles.

**Electoral division no 7: (7,189 voters)**

Consisting of that part of the Ville de Montréal corresponding to the borough of Saint-Laurent.

**Electoral division no 8: (8,727 voters)**

Consisting of that part of the Ville de Montréal corresponding to the borough of Saint-Léonard.

**Electoral division no 9: (7,267 voters)**

Includes the part of the Ville de Montréal corresponding to the borough of Outremont.

Also includes that part of the Ville de Montréal corresponding to the borough of Villeray–Saint-Michel–Parc-Extension.

Also includes the Ville de Mont-Royal.

**Electoral division no 10: (9,986 voters)**

Includes that part of the Ville de Montréal corresponding to the borough of Sud-Ouest.

Also includes that part of the Ville de Montréal corresponding to the borough of Ville-Marie.

Also includes the Ville de Westmount.



If any elector has an objection to the proposed electoral divisions, this objection must be received in writing within 15 days of the publication of this notice. Should 400 or more electors register their objection to the proposal, the Council of Commissioners will hold a public meeting to hear the persons present in respect of the division proposal.
