Daycare Programs: The educators have been busy working on the programs and activities they have planned for the upcoming months in daycare.

B.A.S.E DAYCARE AFTERSCHOOL ACTIVITIES: The daycare was happy to receive extra-curricular after school activities this year. For our Spring Session we will have Latin Groove Dance for Gr 1,2 &4. The students are really enjoying these activities and there was no extra charge to participate!

Daycare & Lunch Supervision Fees: All March invoices were sent out for both daycare and school lunch fees. Payments were due by March 28th, 2025.

We will email daycare statements of accounts for April in mid-April, and they will be due April 30, 2025.

Outstanding Fees: Please note that parents will be contacted to clear any outstanding fees for both daycare and/or lunch supervision. These fees need to be cleared to continue receiving service.

APRIL PED DAY: Due to the upcoming Federal Elections we will have a Ped day on Monday April 28th, 2025. Daycare will be open. We are finalizing our activities for the this ped day and will be sending Ped day Letter to parents shortly. Due date to register for this ped day will be tentatively: April 16, 2025.

Daycare Registrations & Staffing 2025-2026:

We have just received the confirmation that Daycare Registrations 2025-2026 for returning students to Michlenangelo International School will be open through Mosaik from: April 9 -April 23, 2025.

*New students starting in September 2025 will be contacting directly by the Daycare office and cannot register on online as they are not yet set up on Mosaik.

Instructions on how to register for daycare on Mosaik will be sent to all parents shortly.

It is particularly important for us to get this information by April 23rd, 2025, to give us a good indication of how many students will need the daycare services so we can begin preparing our staffing plan and budgets before the late April and early May deadlines.

Important! this registration is only for students who need daycare services.

Parents with students starting Gr 1-6 should NOT be registering on Mosaik solely for lunch supervision. Lunch supervision registrations will be done separately with the school in September 2025.

***Any daycare registration for students starting Gr 1-6, that was accidentally entered for lunch supervision only will be removed and transferred to the school lunch program.**

The only exceptions are students starting PreK & Kindergarten in the fall.

These students need to register for Daycare lunch supervision with the daycare even if they do not need other daycare services in the am & pm.

All students in PreK & Kindergarten are automatically part of daycare for lunch time supervision.

*Special reminder: parents of children who starting Gr 1 in September 2025, and do not need daycare services before and/or afterschool, please note that your child will no longer be under the daycare umbrella for lunch time supervision and will be moved over to the School Lunch Program – you will receive more information on the School Lunch Supervision registrations in September 2025.

DAYCARE DISMISSAL/SAFTEY:

We kindly ask that you make sure to ring the daycare doorbell afterschool when picking up your child to present yourself if the daycare educator is not at the door and does not see you. We also ask you to please make sure you are visible and available when we send your child out. It is sometimes difficult to see parents clearly.

For safety reasons, we cannot send your child to your car.
