- The minister announced that all schools need to be verified for CO2 levels. Levels in 4 different classrooms in different sections of the school were measured. Technicians came in at three different intervals to measure levels. The results at Nesbitt school were very good; CO2 levels need to be under 1000 PPM, Nesbitt's results are 430.
- Windows are still opened as much as possible to help with the air circulation.
- Will the air purifiers be moved if renovations take place? The air purifiers are mounted, new electrical had to be passed. They will try to find a way to transport them to the new temporary building.

3.2. Safe School Plan

• The safe school plan will be reviewed in the Spring. A committee has been formed to look over the plan, which will be presented to GB in Spring.

4. New Business

- 4.1. Sexuality Education Plan 2020-2021
 - The 2020-2021 Sexuality Education plan was presented to GB.
 - We are mandated to have sexual education in our curriculum.
 - The teachers worked on the plan according to the different cycles.
 - The health care professional is the school nurse.
 - The board professional is Jamie Quinn, who does workshops for the teachers.
 - Once the plan is approved, it will be sent to the school board and will be posted on the school's website.
 - Parents are encouraged to ask the teachers should they have any questions regarding the specifics
 of the materials used in class.
 - Will parents be advised ahead of time when a theme will be discussed in class? Depends on the teachers and how they work, if they send a weekly plan, etc.
 - The motion for the Sexuality Education Curriculum Plan was presented to GB and moved by Sophie
 C. The curriculum was approved as presented to the governing board, and communicated via the school website.
 - WHEREAS section 85 of the Education Act states that the curriculum plan for the compulsory content in Sexuality Education must be approved by the school's governing board;
 - WHEREAS the principal, together with a committee of school staff and professionals from the health and social services system, have determined who will provide Sexuality Education content.
 - IT WAS MOVED BY _____Sophie Currie_____ AND RESOLVED THAT the 2020-2021 Sexuality Education Curriculum Plan be approved, as presented, by the Governing Board and that it be communicated to all parents on the school website.

4.2. Budget Building Process 2021-2022

- The budget building process for 2021-2022 was presented to GB.
- Budget Priorities; GB agreed that the 5 priorities will remain as they were in the 2020-2021 report.
- Guiding principles: GB agreed that the 4 guiding principles will remain as they were in the 2020-2021 report.

- Every year Nesbitt is allocated Mesure funds from MEES and must share to GB how those funds will be used. Nesbitt was allocated a total of 17,607\$ for 2020-2021.
