5. Principal's Report

5.1 Daycare Services on a Ped Day

Silvana Crigna explained the procedures for day care services on a Ped Day

- Verified with the Board regarding Ped Day registrations for families GB approval service only available to families that are already registered for services at St Monica regular attendees.
- As long as their children have already been registered for day care services they will be able to attend the Ped day services

- Attendance for vote: 11 people is enough to vote as long as the people present approve that the school will have a PPO and if anyone wants to come forward to be a member can do so tomorrow night
- Covid-19 measures put in place for meeting: safety measures applied therefore no large groups, taking attendance will be done by a staff member. For PPO sign up, everything to be done verbally and notes taken by a designated staff member
