5.1. Principal reports

5.1.1. School Update

Silvana Crigna: Thanks to the PPO for teacher appreciation week

Graduation committee: hoodies were distributed today, yearbook work is in process.

There is still concern for the ceremony being held as usual: option of an outdoor event is being explored to see if this option is viable.

Parent's workshop will be offered soon: 2 parts on mental well-being and building resilience, set on two dates. Instead of refreshments, books were purchased

Student activities: staff is helping in finding resources to organise activities from April to June.

Nadine Collin Joy: option for Graduation: George St-Pierre, tents are available.

5.2. Commissioner's Report

<u>Joseph Lalla</u>: a school rollovers committee was set up, the committee will issue a report by the end of the year. It will be done in time for the adoption of the new budget to support the use of rollovers by schools.

Budget review: there was a surplus budget in the past years except for last year. This year a deficit is projected.

Large sums were spent on Covid measures. There was a letter written to 3 members of parliament and the national assembly about the investment made by the school for Covid measures, we are awaiting an answer.

Français plus program is discussed for Pre-K to grade 4

Tanya MacDonald: Is St-Monica in line to set up this program?

<u>Joseph Lalla</u>: No, we are awaiting for the report in October to see if schools can adopt it for next year. It will be decided by the school boards. One main problem is the shortage of French teachers.

<u>Joseph Lalla</u>: Mr. Lalla was part of the search committee.to appoint a new EMSB Director General. It is on the agenda on March 24th meeting.

5.3. Regional Delegate's Report

On behalf of the Discrimination & Diversity subcommittee, the EMSB PC has forwarded a motion to EPCA asking them to request that all English school boards provide sensitivity training to all teachers and staff on how to have conversations on discrimination, anti-racism, and equality.

Registration is now open for the Virtual Parent Conference. A flyer will be sent to schools soon to be shared with parents. Keynote speaker is Dr. Rubin from the Montreal Children's Hospital and the theme is Resilience through the COVID-19 Pandemic. Registration is free until April 5th, then \$10 afterwards.

<u>Jesse Corbeil:</u> If we keep the composition as it is, and do not fill all positions, what will happen to the board?

<u>Silvana Crigna</u>: 3 attempts will be made to form the Governing Board before the School Board is informed that no Governing Board can be confirmed and it will fall on the Principal to oversee matters of the school. <u>Leighton Jacobs</u> and <u>Cynthia Di Rienzo</u> agree that the proposition might facilitate the formation of new governing boards.

<u>Silvana Crigna</u>: There is a miscomprehension of the time and commitment it requires. We must promote the experience, the contributions and networking that can come from the participation in the Governing Board.

<u>Deema Qasrawi</u>: Covid time has blocked communications between parents in a lot of ways as well. I am proud to be on the board

<u>Tanya MacDonald:</u> the participation online might facilitate or encourage participation.

Silvana Crigna: Online formula can be kept as an option for the future.

Motion suggested to change the composition of governing board:

Due to the difficulties in the past few years in attracting interested parents to participate on the governing board, as well as problems obtaining quorum, Tanya MacDonald proposed to reduce the number of representatives.

After careful discussion, the St. Monica Elementary Governing Board would like to restructure as follows:
