ABOUT THE ORGANIZATION

The QTI Group is partnering with **Three Gaits** to hire its next **Executive Director**.

Founded in 1983, Three Gaits Therapeutic Horsemanship Center has grown to become one of the region's premier therapeutic horsemanship facilities, providing recreational and therapeutic activities for hundreds of participants each year. Our mission is to provide equine-assisted activities and therapies that enhance the lives of people with physical, emotional and/or intellectual challenges. People served by Three Gaits have challenges with conditions such as autism, Down syndrome, learning disabilities, spina bifida, muscular dystrophy, cerebral palsy, brain injury, as well as other numerous disabilities and special needs. Most participants have both intellectual and physical disabilities. Approximately 80% of our participants are children.

Located on 20 acres near Stoughton, Wisconsin, Three Gaits is recognized as a Premier Accredited Center by the Professional Association of Therapeutic Horsemanship (PATH) International. Out of 20 PATH member centers in Wisconsin, Three Gaits is one of only three to hold this accreditation. Three Gaits offers a variety of programming opportunities which include Therapeutic Riding, Hippotherapy, and Unmounted Horsemanship.

Therapeutic Riding

Therapeutic riding contributes to the cognitive, physical, emotional, and social well-being of children and adults with physical, intellectual, and/or emotional disabilities or other special needs. Our therapeutic riding classes incorporate education, competition, therapy, and recreation into horseback riding to build physical strength, develop communication and social skills, and increase self-confidence. Three Gaits instructors are all Certified Therapeutic Riding Instructors by the Professional Association of Therapeutic Horsemanship International (PATH, Inc.).

Hippotherapy

Hippotherapy is an evidence-based treatment tool that uses the movement of the horse as part of an overall strategy for addressing functional limitations in patients with neuromotor and sensory dysfunctions. Using the movement of the horse, sessions are part of a participant's treatment plan as a tool for achieving well-defined functional goals. Three Gaits offers occupational therapy with a licensed occupational therapist and a licensed occupational therapy assistant, both certified by the American Hippotherapy Association (AHA).

Unmounted Horsemanship

For students who cannot ride a horse or are interested in learning about horse care and behavior. Three Gaits teaches horsemanship skills in a safe environment from the ground. Students groom, exercise, and practice horse show leading patterns in Unmounted Horsemanship.

Strategic Leadership

- Lead strategic planning to discover, develop and maintain mutually beneficial community partnerships to increase the financially viable program offerings at Three Gaits.
- Establish and maintain criteria to evaluate existing and new programs to meet community needs and financial success.
- Establish and maintain donor and community partnerships through outreach efforts and community events.

Financial Management and Viability

- Provide guidance and oversight to the Financial Administrator who handles the day-today bookkeeping and payroll.
- Oversee budget development with the Board and manage services to ensure long-term financial viability.
- Create and manage annual budgets and financial statements, prioritizing the financial health of Three Gaits.
- Foresight to identify trends that impact the financial position and revenue of the organization.
- Lead fundraising efforts, including donor cultivation and capital campaigns.

Operational Management

- Manage effective and efficient daily operations of the organization.
- Perform Human Resources activities such as recruiting, hiring, compliance, employee relations, and professional development for staff within the organization.

Board Management

- Demonstrated ability to collaborate and build relationships with diverse volunteers, donor groups, partner agencies, and other constituent groups.
- Budget management skills including budget preparation, analysis, and communication of financial needs to the Board of Directors.
- Strong organizational skills including planning, delegating, program development, and task facilitation.
- Demonstrated clear and effective communication skills.
- Ability to think critically and problem-solve outside of the box.
- Desire to explore advancing technologies to support and promote the Three Gaits organization.
