**ON READING** the Application Records of the parties and on hearing the submissions of counsel for the Applicant and Respondent,


1. **THIS COURT ORDERS** that the Respondent, GZIM BYTYQI, comply with sections 4 and 9 of the *Dentistry Act* and sections 27, 30 and 33 of the *Regulated Health Professions Act*, and in particular, that the Respondent refrain:
  - (i) from using the title "dentist" or "dental surgeon" or a variation, abbreviation or equivalent in English or any other language, in Ontario or in the course of providing or offering to provide, in Ontario, oral health care to individuals;
  - (ii) from using the title "doctor" or a variation, abbreviation or equivalent in English or any other language in the course of providing or offering to provide, in Ontario, oral health care to individuals;

- (iii) from holding himself out as a person who is qualified to practice in Ontario as a dentist or in a specialty of dentistry;
- (iv) from performing any controlled acts in Ontario, or in the course of providing or offering to provide, in Ontario, oral health care to individuals, including but not limited to:
  - (a) performing procedures on tissues below the dermis, below the surface of a mucus membrane, in or below the surfaces of teeth, including the scaling of teeth;
  - (b) administering substances by injection or inhalation;
  - (c) communicating to individuals or their personal representatives a diagnosis identifying any disease or disorder as a cause of symptoms of the individual and circumstance in which it is reasonably foreseeable that the individual or his or her personal representative will rely on the diagnosis; and
  - (d) from dispensing any medication or drugs of any nature or kind.

2. **THIS COURT ORDERS** that there be no costs payable in respect of this application.
