ORDER

THIS APPLICATION by the Royal College of Dental Surgeons for an order that the respondent, Mohamad Ebrahim Hoodfar, comply with section 9 of the *Dentistry Act* and sections 27, 30, 32 and 33 of the *Regulated Health Professions Act* and, in particular, that Mohamad Ebrahim Hoodfar refrain:

- (a) from using the title "dentist" or a variation or abbreviation or equivalent in another language;
- (b) from using the title "doctor" or a variation or abbreviation or equivalent in another language in the course of providing or offering to provide, in Ontario, health care to individuals;
- (c) from holding himself out as a person who is qualified to practise in Ontario as a dentist or in a specialty of dentistry;

- (d) from performing any controlled acts including:
 - (i) performing procedures on tissue below the dermis, below the surface of a mucous membrane, in or below the surfaces of teeth,
 - (ii) administering a substance by injection or inhalation;
 - (iii) fitting or dispensing a dental prosthesis including a denture;
- (e) from treating or advising a person with respect to his or her health in circumstances in which it is reasonably foreseeable that serious physical harm may result from the treatment or advice or from an omission from them;
and
- (f) from designing, constructing, repairing or altering a dental prosthetic device, including dentures,

originally scheduled to be heard on May 7, 1999, but adjourned on consent, was heard this day at Osgoode Hall, 130 Queen Street West, Toronto, Ontario.

ON READING the application record, the applicant's factum, the order of Mr. Justice Wilkins dated May 7, 1999, and on hearing the submissions of counsel for the Applicant, and on being advised that counsel for the Applicant has been authorized by counsel for the Respondent to advise the Court that the Respondent does not oppose the order provided that no costs are ordered:

1. **THIS COURT ORDERS** that the respondent, Mohamad Ebrahim Hoodfar, comply with section 9 of the *Dentistry Act* and sections 27, 30, 32 and 33 of the *Regulated Health Professions Act* and, in particular, that Mohamad Ebrahim Hoodfar refrain:



- (a) from using the title "dentist" or a variation or abbreviation or equivalent in another language;
- (b) from using the title "doctor" or a variation or abbreviation or equivalent in another language in the course of providing or offering to provide, in Ontario, health care to individuals;
- (c) from holding himself out as a person who is qualified to practise in Ontario as a dentist or in a specialty of dentistry;
- (d) from performing any controlled acts including:

 - (ii) administering a substance by injection or inhalation;
 - (iii) fitting or dispensing a dental prosthesis including a denture;
- (e) from treating or advising a person with respect to his or her health in circumstances in which it is reasonably foreseeable that serious physical harm may result from the treatment or advice or from an omission from them; and
- (f) from designing, constructing, repairing or altering a dental prosthetic device, including dentures.
