**O R D E R**

**THIS MOTION**, made by the Applicant for an Order finding the Respondent in contempt of the Order of Justice Dietrich, dated August 13, 2018, was heard on January 31, 2023, at Toronto, Ontario, by video conference.

**ON READING** the Order of Justice Dietrich dated August 13, 2018, the Affidavit of Jamila Karimova affirmed October 25, 2022, the Affidavit of Jennifer Lipiec affirmed November 3, 2022, the Affidavit of Zbigniew Bardel affirmed November 2, 2022, the Affidavit of Yasser Abou-Agena affirmed October 17, 2022, the Affidavit of Abdullatif

Alsoma affirmed January 13, 2023, the Reply Affidavit of Jennifer Lipiec affirmed January 18, 2023, and the Reply Affidavit of Jamila Karimova affirmed January 18, 2023, and the Exhibits attached thereto, and on hearing submissions from counsel for the Applicant and from the Respondent on his own behalf,

1. **THIS COURT FINDS** that the Respondent be and is hereby found in contempt of the Order of Justice Dietrich, dated August 13, 2018 (the “Consent Order”).
2. **THIS COURT ORDERS** that the issue of penalty for the Respondent’s contempt shall be bifurcated.
3. **THIS COURT FURTHER ORDERS** that this matter shall return before Justice A.P. Ramsay on a date to be set to address penalty.
4. **THIS COURT FURTHER ORDERS** that the Respondent may purge his contempt prior to the hearing on penalty.
5. **THIS COURT FURTHER ORDERS** that the issue of costs shall be addressed at the penalty phase of the hearing.
